BOOKING & CANCELLATION GUIDELINES FOR STAR CRUISES

PAYMENT PROCEDURE:

Upon receipt of full passenger's details, Map Holidays & Tours / Star Cruises will send a confirmation Invoice. This will show the booking reference, passenger and cruise details along with the total amount payable. Upon receipt of full payment, Map Holidays & Tours / Star Cruises will issue a confirmation slip that valid for embarkation, where it will be exchange for the Boarding Pass.

Full payment must be forwarded to Map Holidays & Tours before collecting the confirmation slip.

RATES:

a) Christmas and New Year departures, i.e. **holiday surcharge** departures. International Published Rates - applicable on foreigner bookings unless passengers are holding to working permit or resident visa of Pakistan.

b) **MSP** (Minimum Selling Price) - applicable on local bookings and foreigners holding working permit or resident visa of Pakistan or sharing cabin with local national.

c) **45 DAYS EARLY BIRD** - applicable to FIT booking of local national, foreigners holding working permit or resident visa of Pakistan or sharing cabin with local national, at least 45 days prior to departure. Note that EB45 subject to availability.

d) **60 DAYS EARLY BIRD** - applicable to FIT booking of local national, foreigners holding working permit or resident visa of Pakistan or sharing cabin with local national, at least 60 days prior to departure. Note that EB60 is capacity controlled, subject to availability and not applicable on.

e) **GROUP RATES** - applicable to minimum group size of 15 paying cabins and above.

IMMIGRATION REQUIREMENT:

It is the responsibility of the tour operators / agents to ensure that VISA requirements are complied with. We can provide you with full details if you are unsure. **Star cruises have the rights to refuse passenger boarding if the necessary entry visas are not in order. In the circumstances, this will be treated as No Shows and 100% Cancellation charges will be levied**

AMENDMENT POLICY

TRAVEL POLICY

Passage for pregnant women's will only be permitted before their 24th week of pregnancy and doctor's certificate stating that they are fit to travel must be provided. Visa on Arrival is only valid for foreigners, Pakistani Nationals/Citizens for entry into Thailand must apply prior to cruise departure.

Double entry Visa for Thailand is required if pax are traveling to Thailand before or after their cruise. Thai Visa must be applied even if pax do not wish to disembark if the port of calls includes Thailand territory.

On complimentary basis, Malaysian Visa will be arranged for Star Cruises' passengers onboard only.
